The SPD supports the implementation of Policy LP14 of the adopted Babergh and Mid Suffolk Joint Local Plan Part 1 2018-2037 Development Plan Document (November 2023), by providing supplementary information on the issues and considerations that are of relevance to the determination of intensive livestock and poultry planning applications. It provides detailed information and advice based on established good practice for assessing the impacts of new and/or expanded livestock and poultry uses. It also identifies that the in-combination and cumulative impact of proposals must be assessed and provides further guidance on this.
