We wish to continue to provide this community service at an affordable cost of £2 for the first adult, £1 per child and £1 per additional adult. We need to cover the increasing costs of rental of the hall and the increase in cost of food prices. We wish to apply for a grant to cover the cost of a healthy snack provided to children attending the session each week for the current academic year.

Autumn term - 13 sessions

Spring term - 11 sessions

Summer term - 11 sessions

Total sessions = 35

Healthy snack costs £8 per session so total cost for the year $35 \times £8 = £280$

We tend to have between 10-20 families attending each session, children ranging between 0-4 years old and their parents/carers both parent and grandparent age. Most of the families attending are from Thurston village and the rest from surrounding village areas.
