In light of the ongoing cost of living crisis, these services have become increasingly vital.

Citizens Advice Mid Suffolk deliver support through various channels. Telephone consultations, email assistance, and face-to-face meetings. This multi-channel approach ensures accessibility for all community members, regardless of circumstances.

The provision of free, independent advice is designed to help parishioners address their issues before they escalate into crises. Our goal is to empower parishioners with the necessary tools and knowledge to improve their situation.

We will continue to monitor community needs and adapt our services accordingly, striving to reach and assist as many residents as possible.

Citizens Advice Mid Suffolk helped 77 clients in Thurston with 689 issues in the last 12 months. A 44% increase in issues compared to the previous 12-month period.
