In 22/23 we helped 5,418 clients with 28,588 issues. This was an increase of 270 clients based on a comparable outturn of 5.148 in 21/22.

In 22/23 the three highest age groups we supported were:

30 to 34 = 525

35 to 39 = 543

50 to 54 = 519

The continuing financial pressures are very challenging for many people. In the first four months of 2023/24, we have helped 2,277 clients with 8,740 issues. We expect this increase to continue We are currently seeing a significant increase in the multiple number of issues that clients are now approaching with. This often means advice work takes more time and can also be more complex.

We also have projects to help clients living with long term health conditions supported with funding from the National Lottery and Suffolk Community Foundation/East Suffolk & North Essex Foundation Trust. In 2023 we successfully applied for grant funding (National Citizens Advice) to support the significant increase in the numbers of people now being referred to us via the Social Prescribers working with GP's surgeries.
