I am writing to you at the request of the Planning Inspectorate to notify you of an appeal against the above notice. The notice relates to the land mentioned above. This letter is to advise you of the appeal should you wish to make any representations to the Planning Inspectorate as below.

## APPEAL TO ENFORCEMENT NOTICE:

The Appellant has appealed against the Notice to The Planning Inspectorate (a Government Agency) whose address is: -

## THE ENFORCEMENT NOTICE:

The breach of planning control alleged by the Council is:

Without planning permission, the erection of a 1.8m close boarded fence adjacent to the highway and the erection of a 1.8m gate and posts.



#### **REQUIREMENTS OF NOTICE:**

A) Remove the close boarded fence and erect post and rail fencing but not exceeding 1m in height from adjacent ground level, as indicated on plans approved for DC/21/01485 and DC/21/01207, with landscape planting inside the boundary in accordance with approved plans.

B) Remove the gate and associated posts and replace with the picket fencing not exceeding 1m in height, as indicated on the approved plans for DC/21/01207, in order to provide the visibility splay for the site entrance as shown on the approved plans.

## TIME FOR COMPLIANCE FOR NOTICE:

The requirements detailed in Section 4 of this Notice must be complied within one month of the date this Notice takes effect.

## THE COUNCILS STATEMENT OF REASONS FOR ISSUING THE NOTICE:

It appears to the Council that the above breach of planning control has occurred within the last four years.

Permission was granted for the development to have a post and rail fence along the boundary adjacent to the highway. Instead a close boarded fence has been erected which adversely affects the character and appearance of the local area. The Council has refused two planning applications for the fence.

The erection of the fence as built has an unacceptable impact on the character, appearance and setting of the area, contrary to Policies GP1 and H15 of the Mid Suffolk Local Plan 1998, Policy 9 of the Thurston Neighbourhood Plan, Policies LP17 and LP24 of the emerging Joint Local Plan and paragraph 130 of the NPPF.

The erection of the gate and posts results in obstruction of the visibility splay associated with the access to the development. Policy T10 of the Mid Suffolk Local Plan requires the site to have safe access and egress. The gate and its posts impinge on the visibility splay, adversely affecting highway safety and is, therefore, contrary to Policy T10.

## THE GROUNDS OF APPEAL FOR NOTICE:

The appellant has appealed on the following grounds: -

Ground (a) That planning permission should be granted for what is alleged in the notice.

Ground (f) The steps required to comply with the requirements of the notice are excessive, and lesser steps would overcome the objections.

Ground (g) The time given to comply with the notice is too short.



The appeal will be determined by the way of **Written Representations**.

Documents relating to the appeal can be viewed at the Councils offices by prior arrangement.
