Under the Local Transparency Code of 2015, local authorities with gross annual income or expenditure exceeding £200,000 must publish quarterly data which includes all expenditure exceeding £500; government procurement card transations and procurement information for details of every invitation to tender for contracts to provide goods or services with a value that exceeds £5,000. The Council publishes all items of expenditure, including those over £500 by detailing them in the list of payments prepared for approval at each and every full Parish Council Meeting.

Expenditure exceeding £500 - this includes items of expenditure such as: individual invoices; grant payments; expense payments; payments for goods and services; grants; grant in aid: rent; credit notes over £500 and transactions with other public bodies.
